APPLICATION FOR NEW RETAIL LICENCE

Documents required:-

- 1. A certified copy of the applicant's **identity document** and, in the case of a non-Caricom national, a valid work permit [and also proof of residence in Guyana, or proof of domicile in Guyana, as the case may be].
- 2. A **police clearance certificate** if the applicant is an individual.
- 3. Proof of ownership of land or evidence of right to occupy same.
- 4. A certified copy of **business registration** or **incorporation documents** if the applicant is a company.
- Approved plans, final design or construction drawings of all buildings, road works, structures and plant to be erected on the proposed premises, including the location of the proposed premises and a general layout plan thereof.
- 6. A certified copy of **environmental permit** from the Environmental Protection Agency (EPA). If an environmental impact assessment study has been conducted, a certified copy of the document setting out the outcome of such study.
- 7. A list of all storage tanks, capacities and types of products to be stored.
- 8. A copy of the **Petroleum Licence** from Guyana Fire Service (GFS).
- 9. A copy of the Guyana National Bureau of Standards **(GNBS) certificate** verifying pump accuracy.
- 10. Copies of **revenue licences** issued by the Guyana Revenue Authority (GRA), if not a first time applicant.
- 11. Copy of **Tax Compliance Certificate** issued by the Guyana Revenue Authority (GRA).
- 12. Copies of **NIS compliance** if not a first time applicant.
- 13. If retail outlet is branded, for example, by Sol/Rubis/Guyoil, written confirmation by supplying wholesaler.
- 14. A signed declaration of the number of retail outlets already operated by the Applicant.

NOTE WELL

- If applicable, authorization to apply/power of attorney/probate/letters of administration.
- Identification Document of applicant & person authorized to uplift/ transact business.
- Special circumstances- letter with affidavit attached, attesting to special circumstances surrounding inability to furnish requested document(s).
