APPLICATION FOR NEW BULK TRANSPORTATION CARRIER LICENCE

Documents required:-

- 1. A certified copy of the applicant's **identity document** and, in the case of a non-Caricom national, a valid work permit [and also proof of residence in Guyana, or proof of domicile in Guyana, as the case may be].
- 2. A certified copy of **business registration** or **incorporation documents** if the applicant is a company.
- 3. A **police clearance certificate** if the applicant is an individual.
- 4. Copies of **Tax Compliance Certificate** issued by the Guyana Revenue Authority, if not a first time applicant.
- 5. Copies of **NIS compliance** if not a first time applicant.
- 6. For **Vehicles**, provide a copy of:
 - a) Motor Vehicle Registration (only first time applicants).
 - b) Fitness.
 - c) Motor Vehicle Licence.
 - d) Insurance.
 - e) Driver's Licence of all drivers.
 - f) Calibration Certificate from the GNBS, where applicable
 - q) Any permits required for the transportation of goods by any other authority
- 7. For **Vessels** provide a copy of:
 - a) Vessel Registration (only first time applicants).
 - b) Certificate of Inspection from MARAD
 - c) Certificate of Inspection from the Guyana Fire Service, if applicable
 - d) Any other permits required for the transportation of goods by any other authority.
 - e) Captain's Licence for all captains.

Please note that as part of the licensing process all vehicles/vessels must be inspected by the **GEA before licences are granted.** Vehicles/vessels must have the 'NO SMOKING' and 'HIGHLY FLAMMABLE', signs on the sides and back respectively, in 10cm thickness lettering size and an **ABC dry powder extinguisher** on board at all times.

NOTE WELL

- If applicable, authorization to apply/power of attorney/probate/letters of administration.
- Identification Document of applicant & person authorized to uplift/ transact business.
- Special circumstances- letter with affidavit attached, attesting to special circumstances surrounding inability to furnish requested document(s).
