1. The Guyana Energy Agency requires **Sanitization and Pest Control Services** for its **Head Office** and outlying locations in **Regions 2, 7 and 10**. In this regard, you are invited to submit your most competitive bid for provision of the services described below for the period of **one (1) year**.

I. Pest Control Service to Control / Eliminate Roaches, Ants, Rats

II. Sanitization Services to Sanitize Surfaces so that it is made bacteria-free

The item shall be evaluated, and the contract awarded to the firm(s) offering the lowest evaluated price for the services.

2. Funds have been provided by the Government of Guyana.

You shall submit in two (2) forms, that is hardcopy and electronic copy. The bidder will be required to submit one (1) hardcopy and an electronic copy (flash drive only) with an exact PDF version of the Hard Copy Tender bearing the name of the project “ **Provision of Sanitization and Pest Control Services for the Guyana Energy Agency**” at the top left-hand corner on or before 9:00hrs on **November 7, 2024** .

INSTRUCTIONS TO BIDDERS

1. Bid Price

- a) Corrections, if any, shall be made by crossing out, initialling, dating and re writing. *The prices inserted shall be in indelible ink. The use of correction fluid (white -out) is strictly prohibited.*
- b) Prices shall be quoted including all taxes (including Value Added Tax), duties, and other levies paid or payable for delivery of goods to the place of delivery indicated above.
- c) The prices quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- d) The Prices should be quoted in **Guyana Dollars only**.

2. Each bidder is required to submit one (1) hardcopy and an electronic copy (flash drive only) with an exact PDF version of the Hard Copy Tender, the electronic copy (flash drive) must be placed in an envelope bearing the name of the project “**Provision of Sanitization and Pest Control Services for the Guyana Energy Agency**” at the top left-hand corner on or before 9:00hrs on **November 7, 2024** in the MTB tender box at the address above.

3. Bidder shall submit a signed **Bid Securing Declaration** in accordance with Form C found on page 11.

Each bid that exceeds three million dollars (G\$3M) must be accompanied with bid securities as stated in bid Documents.

4. Validity of Quotation

Quotations shall remain valid for a period **not less than 90 days** after the deadline date specified for submission.

5. Evaluation of Quotations

The Procuring Entity shall evaluate and compare quotations, using only the **Evaluation Criteria** as specified in the Request for Quotation.

6. Bidders must have samples of the materials on hand to provide to the Evaluation Committee where applicable

7. Award of Contract

The Procuring Entity will award the contract to the bidder whose quotation has been determined to be the most substantially responsive i.e. having met all the terms and conditions, specifications /requirements and who has offered the lowest evaluated price.

- 7.1 Notwithstanding the above, the Procuring Entity reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- 7.2 The bidder whose bid is accepted will be notified of the award of contract by the Procuring Entity prior to expiration of the quotation validity period.
- 7.3 The successful bidder will be required to enter into a contract with the Procuring Entity in the form and manner specified in the Request for Quotation.
8. Payment shall be made within **seven (7) working days** after delivery of the goods and related services.
9. Normal commercial warranty as provided by manufacturer shall be applicable to all the supplied goods.

10. Liquidated Damages

Applicable rate: *(0.05) percent per week* for untimely execution of order.

Maximum deduction: *10% of the contract price*

11. Settlement of Disputes

Disputes arising out of or in connection with the Contract shall be settled in accordance with the Laws of Guyana.

13. Retention

No retention shall be applied on consumables, but warranties /guarantees and expiry dates do apply.

4. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Procuring Entity to provide the Goods, and remedy defects therein in conformity in all respects with the provisions of the Contract.
5. The Procuring Entity hereby agrees to pay the Supplier in consideration of the delivery of the Goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.

1. Pest Control Service to Control / Eliminate Roaches, Ants, Rats

- a) Region 4 - At GEA's head office located at 295 Quamina Street, South Cummingsburg, Georgetown.
- b) Region 2 - At Golden Fleece, Essequibo.
- c) Region 7 - At 7th Avenue, Bartica
- d) Region 10 - At GEA's outpost located at McKenzie Bridge, Linden.

Pest control services is required once per quarter for one year.

2. Sanitization Services to Sanitize Surfaces so that it is made bacteria - free

- e) Region 4 - At GEA's head office located at 295 Quamina Street, South Cummingsburg, Georgetown.
- f) Region 2 - At GEA's Golden Fleece, Essequibo Base
- g) Region 7 - At GEA's 7th Avenue, Bartica Base

Sanitization Services is required to be done monthly for one year.

3. Sanitact Service

Sanitact Services is required to be done once per month for one year.

4. Toilet seat Sanitizer Service – Install and Refill sanitizers toilet seats.

- b) Region 4 - At GEA's head office located at 295 Quamina Street, South Cummingsburg, Georgetown for a total of fourteen (14) washrooms.

Toilet seat sanitizer services is required to be done once per month for each washroom.

Bidders are required to submit a copy of a valid license from the Pesticides and Toxic Chemicals Control Board and list at least three (3) similar works completed in the last three years
